Product description

Roof drainage system consisting of gutters and associated components of semi-circular cross section and down-pipes and pipe components of circular cross section. The gutters and down pipes are made of hot-dip galvanized and painted steel sheet, or aluminium-zinc coated steel sheet, both with thickness 0.6 - 0.7 mm. The gutter brackets are made of hot-dip galvanized and painted steel strip with a thickness of 5 mm.

Intended use

Collection and drainage of rainwater and melted snow from roofs.
